UNCONDITIONAL RELEASE and WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

1. I am participating in a prospecting outing and various other events with Nye Gold Seekers, a nonprofit 501(C) (3). I recognize that I am responsible for my own safety while on these events which includes travel and on site activities.
2. I acknowledge that the activities of the events can be dangerous and may involve the risk of serious injuries, death or property damage. I also expressly acknowledge that injuries may be compounded or increased by negligent rescue operations or procedures of the releases.
3. I hereby release, waive, discharge and covenant not to sue the organizations, participants, associations, or organizers of these events. I am aware that the officers of Nye Gold Seekers, Pahrump, Nevada, any and all members of Nye Gold Seekers, and any and all of its officers, members and affiliates have not sanctioned or provided any assurances for the safety and or wellbeing of any and all participants for this event. I realize I may be crossing the surface of others who have mining claims or may be property owners in order to get to the site.
4. I have also released, as part of this unconditional release, any responsibility I may have for the safety of others. I recognize the terrain will be hilly, rocky, slippery at times, is located at an altitude different than that where I live, and the roadway is passable but not paved and not as wide as normal two lane roads. Vehicular transportation such as automobile, four wheeler, RV and Van are most likely suitable for these events.
5. I am aware there is no insurance or other security instrument provided by any entity for these events and I must provide for my own insurance and security as I may desire. I assume full responsibility for any risk of bodily injury, death or property damage arising out of or related to the events(s) whether caused by the negligence of the releases or otherwise.
6. I agree to indemnify and save and hold harmless the releases and each of them FROM ANY LOSS, LIABILITY, DAMAGE, and OR COST they may incur arising out of or related to the UNDERSIGNED INJURY OR DEATH, WHETHER CAUSED BY THE RELEASEES OR OTHERWISE.
7. I hereby assume FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to events whether caused by the negligence of releases or otherwise.
8. Severability. I hereby agree that this release and waiver of liability, assumption of risk and indemnity agreement extends to all acts of negligence by the releases, INCLUDING NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES, and is intended to be as broad and inclusive as is permitted by the laws of the State of Nevada. If any portion is held invalid, the remaining portions of the agreement shall remain in full legal force and effect. I may receive recommendations as to items to bring for events and acknowledge that they are bare bones requirements and are in no way to be construed as mandatory for safety, or participation in any events. I am free to include additional items as I see fit to bring. I have received a copy of this document and understand its terms, that I have given up substantial rights by signing it and have freely and voluntarily, without inducement, assurance or guarantee being made to me and extend my signature to be a complete and unconditional release of any and all liability to the greatest extent allowed by law.
